Recital Participation Fees

Company & Non-Company Students

1 per student, per season. These fees do not include costume expenses. **DUE JAN 15, 2024.**

- Pre-Dance 1 & 2--\$75.00
- Levels A-1 & A-2—85.00
- Beginning & Beg/Int Levels--\$90.00
- Intermediate Levels--\$95.00
- Int/Adv Levels (NON-company) --\$100.00
- Company--\$115.00

Costume Fees (per dance/per class)

Costume fee payments do not cover the cost of any tights, shoes or undergarments a student may need to purchase to wear with their costumes.

- Each family will need to pay a costume fee for every performance dance in which their dancer plans to participate.
- **\$75, per costume, will be DUE by JAN 30, 2024, for each class in which your dancer participates.**
- **Costume Closet:** CDC does have some costume inventory in its company Costume Closet. **If/when we choose to use a Costume Closet costume for your dancer's class, we will notify you before your Jan 30 payment. If you have already paid for a new costume and we then choose something from our inventory, we will refund any over-payment to your account. The charge for the use of each Costume Closet costume is \$30.** CDC keeps all Costume Closet costumes after performances. These costumes are not to go home with dancers after their use in a performance. The usage fee is used to cover the cost of cleaning, storage and maintenance of these costumes.
- CDC may, on rare or special occasions, approve costume choices above \$75 in cost for ONLY Int/Adv Classes, Company pieces or soloists. We will notify dancers' families ahead of time when/if that is the case.
- There may be additional shipping charges added to your account **if your dancer's costume needs to be returned or exchanged for sizing or any other reason.** You will not be charged an additional amount if the amount you paid covers the cost of the costume plus any additional shipping charges.
- There may be additional charges added to your account **if your dancer's costume needs to be altered by a seamstress,** (when obtaining a different size from a vendor is not an option). You will not be charged an additional amount if the amount you paid

covers the cost of your costume plus the cost of the alterations.

- Payment plans for costume expenses are available upon request.
- **A \$25 late fee will be added for every 30 days a balance remains outstanding for the payment of costumes.** This may be avoided if a family specifically arranges a payment plan and/or delayed due date with the owner of the studio.

Additional Company Participation Fees

Senior and Junior Company Students Only

No scholarship funds available for company fees. Late fees will apply when 5 days past due and for every additional 15 days after.

- Junior Co: \$85.00 **DUE OCT 2, 2023**

1st Semester Holiday Show Costume Usage Fee

- Senior Co: \$75.00 (Total, NOT per costume)
- Junior Co: \$55.00 (Total, NOT per costume)

Will be charged if we order costumes not already in our costume closet inventory.

Enrichment/Master Class/Guest Teacher Fee

Senior Company Only

- \$20/month **DUE w/ tuition payment OR**
- \$120/Semester **DUE SEPT 1, 2023 & FEB 1, 2024**

2nd Semester Company Participation Fee

- Senior Co: \$125.00 **DUE FEB 1, 2024**
- Junior Co: \$85.00 **DUE FEB 1, 2024**

Costume Closet Usage for 2nd Semester Recital

- CDC will utilize costumes from the Company Costume Closet for company pieces where appropriate. **There will be a \$30 fee charged for the use of each "old" Company Costume Closet costume for the recital.**
- New costume purchases for costumes to be added to the Company Costume Closet will be charged to each family at 50% or less of the vendor's price. CDC will pay 50% or more of the new costume purchase price and will then keep the costume in inventory for current and future use.
