#### Recital Participation & Video Fee

**\*NOW INCLUDES 1 RECITAL VIDEO PER STUDENT\***

1 recital participation fee per student, per season. This fee **DOES NOT** cover costume expenses. **DUE JAN 13, 2025.**

- Pre-Dance-- \$110.00 (includes 1 recording)
- A-1 & A-2-- \$120.00 (includes 1 recording)
- Beg & Beg/Int-- \$125.00 (includes 1 recording)
- Junior & Int-- \$130.00 (includes 1 recording)
- Int/Adv-- \$140.00 (includes 1 recording)
- Jr Company-- \$140.00 (includes 1 recording)
- Sr Company-- \$150.00 (includes 1 recording)

#### Costume Fees (per dance/per class)

Costume fee payments do **not** cover the cost of any tights, shoes or undergarments a student may need to purchase to wear with their costumes. Those items will need to be purchased by each family shortly before the show.

- Each family will need to pay a costume fee for every performance dance in which their dancer plans to participate. (Example: Student enrolled in 4 junior classes/week will pay \$300 for costumes).
- **Pre-Dance Through Junior Level: \$75 per costume will be DUE by FEB 1, 2025, for each class in which your dancer participates.**
- **Intermediate Level Through Sr Company: \$85 per costume will be DUE by FEB 1, 2025, for each class in which your dancer participates.**
- **Costume Closet:** CDC does have some costume inventory in its company Costume Closet. **The charge for the use of each USED Costume Closet costume is \$40.** CDC keeps all Costume Closet costumes after performances. These costumes are not to go home with dancers after their use in a performance. The usage fee is used to cover the cost of cleaning, storage and maintenance of these costumes.
- CDC may, on rare or special occasions, approve costume choices above \$85 in cost for ONLY Int/Adv Classes, Company pieces or soloists. We will notify dancers' families when/if that is the case.
- There may be additional shipping charges added to your account **if your dancer's costume needs to be returned or exchanged for sizing or any other reason.** You will not be charged an additional amount if the amount you paid covers the cost of the costume plus any additional shipping charges.
- There may be additional charges added to your account **if your dancer's costume needs to be altered by a seamstress,** (when obtaining a different

size from a vendor is not an option). You will not be charged an additional amount if the amount you paid covers the cost of your costume plus the cost of the alterations.

- Payment plans for costume expenses are available upon request.
- **A \$25 late fee will be added for every 30 days a balance remains outstanding for the payment of costumes.** This may be avoided if a family specifically arranges a payment plan and/or delayed due date with the owner of the studio.

- Junior Co: \$ 85.00 **DUE FEB 1, 2025**

#### New Purchases for Company Costume Closet

If applicable, new costume purchases for costumes to be added to the Company Costume Closet will be charged to each family at 50% or less of the vendor's price. CDC will pay 50% or more of the new costume purchase price and will then keep the costume in inventory for current and future use.
